SPRING COURT "PRIVILEGE CLUB" MEMBERSHIP TERMS AND CONDITIONS

1. 1 year from date of sign up. Sign –up Fee at S\$28.
- Sign-Up Bonus**
2. Bonus of P\$32 (sign-up bonus) is valid for redemption from next visit onwards, valid for 1 month.
- Issuance of P\$**
3. Members earn 10% REBATE on ala carte food orders and regular set menus.
4. Rebate is applicable to the balanced amount on the stipulated items, after P\$ Redemption.
5. Rebate is not applicable for Promotional Items,Beverages, Desserts, Merchandise, Chinese Tea, Pickles & Towels.
6. Rebate is not applicable on eve of Chinese New Year.
7. Service charge & GST will not be applicable for any rebates.
8. The rebate will be accumulated as P\$ for future redemptions. P\$1=SS\$1.
9. Mobile number must be provided at the time of dining for verification purposes.
- Redemption of P\$**
10. Members must be present for the redemption of P\$.
11. Redemption of PS is up to 50% of the bill and is valid for a maximum of 3 tables of 10 persons each only (i.e. not more than 30 persons).
